Two Post-Doctoral Positions under the DST Project Indian Beamline at Photon Factory, KEK, Japan – Phase II

Applications are invited from eligible candidates under the above mentioned project for a minimum period of one year for carrying out scientific responsibilities and to support users of the Indian Beamline. The selected candidates will be posted for approximately 6 months in KEK and remaining period of the year in India. The period of stay in Japan or India may change depending on activities in the beamline. For details about Beamline Project/Facility, visit website <http://www.saha.ac.in/web/photon-factory-home>.

Eligibility: Indian nationals with a Ph.D. degree in science (preferably in the areas of Physics, Chemistry or Materials Science). Those who have finished their thesis work but yet to receive Ph.D. degree can also send their applications by attaching a confirmation letter from Ph.D. guide. Candidates having experience in powder X-ray diffraction in high pressure, low temperature and/or experience in surface scattering techniques like reflectivity, GISAXS will get preference. Those holding a permanent position are also encouraged to apply for a deputation through proper channel, preferably sending an advanced copy by e-mail.

Remuneration: Candidates with Ph.D. degree when posted at KEK, Japan will be paid a remuneration inclusive of subsistence allowance of approximately Rs 210,000 per month (equivalent to JPY 330,000 at present conversion rate) during posting in KEK, Japan. When posted in India, they will be paid Rs 50,000 (fixed) p.m. Candidates who have not received the Ph.D. degree will be paid approximately Rs 153,000 per month (equivalent to JPY 240,000 at present conversion rate) and when posted in India, they will be paid a remuneration of Rs 35,000 p.m. (fixed).
