INLAKS FOUNDATION SCHOLARSHIPS ABROAD (1984-1986)

The Inlaks Scholarships are offered for studies and specialization in various fields of activity. They are awarded after the screening of application forms and several personal interviews. The scholarships will be for one or two years and include all expenses.

There are two kinds of scholarships: (A) Undergraduate or Graduate study in all subjects offered at Cambridge, Harvard Law School, Imperial College (London), London School of Economics, Oxford, Pratt Institute and Royal College of Art. Or Graduate courses in any subject offered by any American University for which candidates have secured admission before applying. (B) Professional

programmes or programmes not towards a degree. They can be at an institution, academic or otherwise. They can also include independent self-directed study or research.

Applications are invited from Indian citizens aged 19-24 (at the time of application) who possess a good undergraduate degree.
