Applications on plain paper with complete bio-data including contact details (phone number, e-mail address and postal address) along with photocopies of educational/professional qualifications, mark sheets, reprints of papers, etc. are invited from Indian nationals for one temporary post of Senior Research Fellow/Research Associate for the project entitled '**Synthesis of IP<sub>3</sub> analog libraries using click chemistry and their biological evaluation**' sponsored by CSIR (Council of Scientific and Industrial Research, Govt of India) at School of Chemistry, IISER, Thiruvananthapuram. The research experience claim should be supported with experience certificate from previous employer. The initial appointment will be for a year but extendable up to three years based on the performance. ### Eligibility:

- (1) For SRF: M.Sc. with 55% marks and two years of research experience in synthetic organic chemistry/SRF of CSIR with 55% marks in M.Sc. (chemistry).
- (2) For RA: Ph.D. in organic chemistry with proven research excellence in terms of publications/patents, etc. and with at least 55% marks at the M.Sc. level/RA-ship of CSIR with at least 55% marks at the M.Sc. level.

**Age:** The upper age limit for SRF and RA shall be 32 and 35 years respectively on the day of application. A relaxation of 5 years is applicable to candidates belonging to SC/ST/OBC and women candidates.

**Stipend:** Monthly stipend of Rs 14,000 for SRF and Rs 16,000/17,000/18,000 depending on the experience for RA will be admissible as per CSIR norms.

**Note:** Mere fulfillment of qualifications/experience requirements does not entitle a candidate to be called for the interview. Only short-listed candidates will be called for telephonic and/or personal interview. Selected candidate will be intimated by post/e-mail.
